## Social Security Programs and Related Benefits Desk Guide pages 25-28

TERM	MEANING	EXPLANATION
DAC	Disabled Adult Child (Title II)	A type of benefit available under Title II.
DIB	Disability Insurance Benefits	Another term used for SSDI benefits.
SDI	State Disability Insurance	Refers to a state-run program for short-term disability benefits. In CA, EDD administers the SDI program. It is not an SSA program.
SSA	Social Security Administration	, ,
SSI	Supplemental Security Income	Program available to low-income individuals who are disabled or 65 or older.
SSDI	Social Security Disability Insurance	Program available to individuals who are disabled and have sufficient work credits to be insured.
Title 2/Title II	Title II of the Social Security Act Frequently used to refer to SSDI.	Laws that cover programs under "OASDI" (Old-Age, Survivor, Disability Insurance) https://www.ssa.gov/OP_Home/ssact/title02/0200.htm
Title 16/Title XVI	Title 16 of the Social Security Act Refers to SSI.	Laws related to the SSI Program. https://www.ssa.gov/OP_Home/ssact/title16b/1600.htm
UI	Unemployment Insurance	Refers to state-run unemployment insurance programs. In CA, EDD administers the UI program.
WC	Worker's Compensation	State-funded program paid by employers. Provides benefits to individuals with work-related injuries.





### Social Security Offices, Organization, & Structure Desk Guide pages 25-28

TERM	MEANING	EXPLANATION
AC	Appeals Council	Level of appeal after an Administrative Law Judge Hearing.
ALJ	Administrative Law Judge	Individual who decides the case at hearing.
CFR	Code of Federal Regulations	
DDS	Disability Determination Service	State agency contracted by SSA to make disability determinations at the initial and reconsideration stages of the SSA claims process.
F0	Field Office	The name for local SSA offices that have responsibility for specific zip codes.  SSA also calls these a "D0" or "District Office"
OASDI or Title II	Old-Age, Survivor and Disability Insurance	This refers to all of the SSA programs included in Title II of the Social Security Act.  The programs included are: Social Security Retirement, SSDI, Disabled Adult Child Benefits, and Survivor's Benefits.
0H0	Office of Hearing Operations	The SSA Hearing Office that hears and decides hearing-level appeals.  Appeals are decided by Administrative Law Judges (ALJs).
OP	Overpayment	When a claimant has been paid more benefits than they were entitled to, they owe money to SSA. This is an "overpayment."
POMS	Program Operations Manual System	This is the claims manual that gives detailed instructions to SSA Field Office staff on how to process claims for benefits. It's their user manual.





## Common Social Security Medical Terms Desk Guide pages 25-28


TERM	MEANING	EXPLANATION
ADL	Activities of Daily Living	What a disabled person (claimant) does on a typical day. Gathered in the Function Report.
AOD	Alleged Onset Date	The date the claimant stated in application that they last worked or that they believe their disability began.
CE	Consultative Examination or Consultative Examiner	Doctors contracted by SSA/DDS to do medical exams of claimants in order to gather additional evidence.
DAA	Drug Addiction and/or Alcoholism	Abbreviation SSA uses for substance use disorders.
EOD	Established Onset of Disability	The date that SSA/DDS has determined a claimant was disabled under SSA rules.
MRFC	Mental Residual Functional Capacity	What work-related activities a claimant is able to do from a mental standpoint.
RFC	Residual Functional Capacity	Term used to describe what work-related activities a claimant is still able to do from a physical stand-point.



### Social Security Rules and Technical Terms Desk Guide pages 25-28

TERM	MEANING	EXPLANATION
Credits	Previously called "Quarters of Coverage"	The credits that an individual has from paying Social Security taxes while working. One can earn a maximum of 4 credits per year.  Most people need 40 credits to qualify for SSDI or Retirement.
DLI	Date Last Insured .	The last date on which a claimant is still insured for SSDI benefits. Claimant must prove they became disabled prior to this date or they will not be approved for SSDI.
Earnings Record	Record of what an individual has earned on their Social Security Record	Only earnings on which Social Security taxes have been paid will show up on an Earnings Record. It is used to determine credits and whether an individual is insured.
FICA Tax	Federal Insurance Contributions Act	It is the tax withheld from wages that funds the Social Security and Medicare programs.
Full Retirement Age	The age at which an individual is able to collect their full retirement amount	The age depends on the year you were born. <a href="https://www.ssa.gov/benefits/retirement/planner/ageincrease.html">https://www.ssa.gov/benefits/retirement/planner/ageincrease.html</a>
Insured Status	Whether or not an individual has enough credits to be eligible for Title II programs	One has insured status if they worked and earned enough Social Security credits to be eligible for benefits (or for their dependents to be eligible) due to the worker's retirement, disability or death.
ISM	In-kind Support and Maintenance	A term used in the SSI program for when an SSI recipient receives some food and/or shelter for free each month.
PRW	Past Relevant Work	The term SSA uses for the work history that will be looked at in a disability evaluation to determine if a claimant is able to return to work.
SGA	Substantial Gainful Activity	A monthly earnings amount set by SSA (increases each year). Generally, if a claimant earns above this amount in a month they will not be considered disabled by SSA.









#### SSDI Denial Notice - Date Last Insured

SOCIAL SECURITY ADMINISTRATION
RETIREMENT, SURVIVORS, AND DISABILITY INSURANCE
Notice of Disapproved Claims

"Old-Age, Survivor and Disability Insurance" - This notice is just about SSDI

In order to be entitled for benefits your condition must be found to be severe prior to 12/31/2018. The evidence in file is not sufficient to fully evaluate your claim and the evidence needed cannot be obtained. We have determined your condition was not disabling on any date through 12/31/2018, when you were last insured for disability benefits. In deciding this, we considered the medical records, your statements, and how your condition affected your ability to work.

**Information About Substantial Work** 

"DLI" & "SGA" - Client is denied because they could perform substantial gainful activity on their date last insured

Usually, we find that work is substantial if gross earnings average over \$1260 per month after we deduct allowable amounts. This monthly amount is higher for Social Security disability benefits due to blindness.
